Laporan Dewan Komisaris

Pemegang Saham yang terhormat,

Dewan Komisaris telah mengkaji strategi dan kebijakan bisnis yang dibuat dan dijalankan oleh Manajemen Perseroan dibawah pengawasan dan arahan Direksi pada tahun 2014, dan telah menerima laporan mengenai kegiatan PT Centex Tbk ("Perseroan") serta laporan manajemen dari Dewan Direksi, dan kami telah mempelajari posisi keuangan Perseroan tanggal 31 Desember 2014 serta hasil operasinya dan arus kas untuk periode yang berakhir 31 Desember 2014 yang telah diaudit oleh Kantor Akuntan Publik "KPMG Siddharta Widjaja & Rekan" No.L.14-157-15/II.30.001 tanggal 30 Maret 2015, kami memberikan persetujuan kepada laporan-laporan tersebut.

Industri tekstil dan produk tekstil (TPT) pada tahun 2014 masih menghadapi tantangan yang terus berlanjut dari tahun-tahun sebelumnya. Faktor utama yang sangat mempengaruhi kondisi usaha pertekstilan adalah seperti tingginya biaya tenaga kerja dan tingginya biaya pemakalan listrik Industri.

Perseroan juga menghadapi berbagai tantangan dan persaingan. Meskipun menghadapi tantangan, tidak berarti kami harus menyerah dengan keadaan. Kami melihat manajemen telah melakukan berbagai upaya untuk tetap bisa tumbuh dengan baik. Direksi telah membuktikan kompetensinya dalam mengembangkan usaha Perseroan melalui kinerja yang berkesinambungan serta manajemen yang mampu menjalankan program-program yang telah direncanakan sehingga dideapatkan terobosan yang lebih baik.

Pada tahun 2014 Perseroan mengalami peningkatan nilai penjualan dari US\$31.193 ribu pada tahun 2013 menjadi US\$34.415 ribu, naik sebesar US\$3.222 ribu atau sekitar 10,33%. Peningkatan nilai penjualan terutama disebabkan oleh permintaan pasar yang membikin.

Perseroan mencatatkan Laba tahun berjalan sebesar US\$5.286 ribu pada tahun 2014, naik dibandingkan dengan rugi tahun 2013 sebesar US\$5.113 ribu.

Secara umum kinerja tersebut meningkat dibandingkan dengan tahun 2013. Sehubungan dengan kinerja Perseroan pada tahun 2014, kami sarankan kepada Direksi untuk meningkatkan daya saing produk Perseroan baik dari sisi kualitas maupun harga di pasar lokal maupun ekspor melalui pengembangan pasar strategis dengan inovasi yang kuat.

Dear Distinguished Shareholders,

The Board of Commissioners has reviewed the business strategic and policies formulated and implemented by the management of the Company under the supervision and guidance of the Board of Directors in 2014, and received the report on PT Centex Tbk (the "Company")'s activities and management reports submitted by the Board of Directors, and we have studied the financial position of the Company as of 31 December 2014, and the results of its operations and its cash flows for period ended 31 December 2014, which have been audited by the public accounting firm of "KPMG Siddharta Widjaja & Rekan" No. L.14-157-15/II.30.001 dated 30 March 2015, we provide approval on the financial statements.

The Industries of textile and textile products (TPT) in the 2014 still faces a continuous challenges from previous years. The main factors that affected the condition of business textile due to, the high of labor cost and the increase of electricity price for industry.

The Company also faces a variety of challenges and competition. Even though faced many challenges, it did not mean by the Company surrender to the circumstances. Directors have been proven their competency in developing the Company's business through continuous performances and management which able to run program that have been planned to obtain better breakthroughs.

In 2014 the company increased in the value of sales from US\$31,193 thousand in the 2013 to US\$34,415 thousand, Increased US\$3,222 thousand or 10,33% . Increased sales mainly due to demand of the market is improve in this year.

The company's recorded profit for the year of US\$5,286 thousand in the 2014, increase compared to loss in the 2013, of US\$5,113 thousand.

The generally is performance improved than in 2013. With respect to the company's performance in the year 2014, we recommend to the Board of Directors to increase the Company's competitiveness both in the quality and good prices in the local market and export through strategic market development with strong innovation.




