Berdasarkan Keputusan Menteri Kesehatan Nomor 129 Tahun 2008 tentang Standar Minimal Pelayanan di Rumah Sakit, pengisian berkas rekam medis harus 100% lengkap. Semua hasil tindakan medis yang diberikan kepada pasien harus ditulis lengkap pada setiap lembar diberkas rekam medis salah satunya pada formulir laporan operasi. Laporan operasi adalah catatan medis mengenai prosedur pembedahan terhadap pasien. Tujuan dilakukannya penelitian ini adalah untuk mengetahui gambaran kelengkapan pengisian formulir laporan operasi di RSUD Koja. Penelitian ini metode penelitian deskriptif dengan pendekatan kuantitatif. Hasil rekapitulasi kelengkapan yang didapat terhadap 94 rekam medis yaitu sebesar 90,20% meliputi identifikasi pasien 98,67%, catatan yang penting 90,66%, autentikasi penulis 96,63%, dan catatan yang baik 74,82%. Ketidaklengkapan tersebut disebabkan karena, belum dibuatnya SPO pengisian laporan operasi, tingkat kepedulian dokter operator terhadap kelengkapan laporan operasi masih rendah, dan belum dilakukannya kegiatan analisis kuantitatif pada laporan operasi. maka sebaiknya pihak rumah sakit segera membuat spo pengisian laporan operasi, mensosialisasikanya ke tenaga medis terutama dokter operator untuk mengisi laporan operasi dengan lengkap, dan dilaksanakannya kegiatan analisis kuantitatif pada laporan operasi.

ABSTRACT

Based on the Decree of the Minister of Health Number 129 of 2008 concerning Minimum Service Standards in Hospitals, the filling of medical record files must be 100% complete. All results of medical actions given to patients must be written in full on each sheet of the medical record file, one of which is the surgery report form. The surgery report is a medical record of the surgical procedure on the patient. The purpose of this study was to describe the completeness of filling out the surgery report form at Koja Hospital. This study uses descriptive research methods with quantitative analysis. The results of the completeness recapitulation obtained for 94 medical records are 90.20% including patient identification 98.67%, important notes 90.66%, author authentication 96.63%, and good records 74.82%. This incompleteness is due to the fact that the SOP for filling out the surgery report has not been made, the level of concern of the operating doctor on the completeness of the surgery report is still low, and the quantitative analysis activities in the surgery report have not been carried out. then the hospital should immediately make a SPO for filling out the operation report, socialize it to medical personnel, especially the operator doctor to fill out the complete operation report, and carry out quantitative analysis activities in the surgery report.
