Brief History: The company, founded in 1981, was originally named PT Berlian Laju Tanker and assumed its present name in 1988. The company's main line of business is the operation of both company owned and chartered tankers for the transportation of liquid chemicals, oils crude/products, liquefied gas, molasses and edible oils. The company, at present, controls and operates 19 tankers of various types and sizes. Some of the tankers are currently chartered by PERTAMINA for the transportation of crude and oil products, and the rest is engaged in spot market transportation and contract of affreightment with a private/major oils company. The company has also worked together with foreign shipping companies in agency and marketing net works. The company's branch is located at Merak Port, which covers Anyer and Bojonegoro as the operational network. At the end of 1994 the company opened branch offices in Dumai and Pekanbaru. The company has obtained US\$ 24 million in funds from Marubeni Corporation to purchase chemical tanker ship. The first vessel with 5,600 tons capacity will be built by Fukuoka Shipbuilding at US\$ 15 million, launched on April 1997. The second ship smaller vessel with 3,200 tons capacity will be built by Shitanoe Shipbuilding at US\$ 9 million, and will be operated on December 1996. The company also has branches and representative offices throughout Indonesia ports. The company has obtained US\$ 24 million in funds from Marubeni Corporation to purchase chemical tanker ship. In early 1998, the company has purchased 19 new tankers from Japan and Korea, with a total amount of US\$ 230 million. It will also acquire 100% of Malaysian Asian Maritime Corporation and Singapore Union Shipping's share. At the end of 1998, Berlian Laju Tanker added eight vessels to its fleet, bringing the total to twenty-five. Five of these additional vessels came from the US\$ 45 million acquisition of Asian Maritime Corp. on July 5 last year. To bolster its market network in Southeast Asia, the firm is set to invest in two transports service companies in the Philippines and Thailand.





Although the building of the power plant is possibly postponed due to currency crisis, the company persisted on providing several ships to its fleet by purchasing 4 new ships worth US\$ 7 million. By doing this, the company presently has 30 ships. Early in year 2002, Fraser Securities Pte. Ltd. Singapore bought up 11.38% of the company's shares as a long term investment.



Financial Performance: In 2004 the Company was suffered loss on sale of non-operational assets at Rp 34.047 billion. The Company was booked net loss at Rp 45.650 billion, while last year booked income at Rp 3.039 billion.
Brief History: The company was established in 1971, under the name PT Tanda Widjaja Sakti. In December 1993, in preparation for the public offering of its share, the company changed its name to PT Steady Safe. The start-up with license to operate 150 vehicle as taxi for Jakarta has today become premier mass Transportation Company. Steady Safe has introduced the Indonesian capital's first privately managed Air Conditioned buses and now operates 12 pool and workshop in the greater Jakarta area for the logistical and technical support requirements of its taxi and bus fleets. On July 20, 1994, the company listed its share on Jakarta Stock Exchange. In 1997, the company embarked on expansion program involving the procurement of 1,000 buses, investment in passenger ferry, terminal operation, and investment in toll-road operation through the acquisition of 14.2% of the outstanding capital of PT Cipta Marga Nusaphala Persada (CMNP). These investment initiative were initially funded by bridging loan facility from Peregrine Fixed Income Limited (PFIL), while the company's debt placement overseas were being worked out. On November 28, 2001, the company and PFIL signed the Settlement Agreement that provides the final solution to the settlement of the company's US \$ 281 million debt to PFIL. SA was recently became effective on March 14, 2002 and its execution is going and is expected to be completed by the end of year 2002. The company has twelve majority-owned subsidiaries: PT Buana Metropolitan Taxi, PT Citra Pancakabraja, PT Fajar Utama Semesta, PT Has Muda Internusa, PT Infiniti Indosakti, PT Luhursatri Dwiraya, PT Mastrans Swadarma, PT Sembada Permai Sejati, PT Sonnypong Yatim, Steady Safe Finance BV, PT Volgren Indonesia, and PT Wahana Artha Sentosa.



Financial Performance: The Company has managed to book net profit at IDR758 billion in 2007, declining from IDR1.205 trillion in 2006. The net profit decrease was partly contributed from fixed assets sales from IDR482 billion to IDR27 billion.

Brief History: The company, founded in 1981, was originally named PT Berlian Laju Tanker and assumed its present name in 1988. The company's main line of business is the operation of both company owned and chartered tankers for the transportation of liquid chemicals, oils crude/products, liquefied gas, molasses and edible oils. The company, at present, controls and operates 19 tankers of various types and sizes. Some of the tankers are currently chartered by PERTAMINA for the transportation of crude and oil products, and the rest is engaged in spot market transportation and contract of affreightment with a private/major oils company.

The company has also worked together with foreign shipping companies in agency and marketing net works. The company's branch is located at Merak Port, which covers Anyer and Bojonegoro as the operational network. At the end of 1994 the company opened branch offices in Dumai and Pakanbaru. The first vessel with 5,600 tons capacity will be built by Fukuoka Shipbuilding at US\$ 15 million, launched on April 1997. The second ship smaller vessel with 3,200 tons capacity will be built by Shitanoe Shipbuilding at US\$ 9 million, and will be operated on December 1996. The company also has branches and representative offices throughout Indonesia ports. In early 1998, the company has purchased 19 new tankers from Japan and Korea, with a total amount of US\$ 230 million. It will also acquire 100% of Malaysian Asian Maritime Corporation and Singapore Union Shipping's share. At the end of 1998, Berlian Laju Tanker added eight vessels to its fleet, bringing the total to twenty-five.







Financial Performance: In 2007, The Company recorded consolidated net income at USD2.998 million or higher than USD1.717 million which the company had in 2006. The higher net income was partly due to the increase in net revenues from USD 33.827 million to USD48.180 million.

Brief History: Supported by a fleet of 23 vessels since 1988, the company expanded its operation to other form that included coal and aggregate transportation. In its activities, the company has cooperated with Chuan Hup Holdings Ltd. of Singapore, one of its major shareholders. In 1996, net profit for its shipping services reached Rp 8,12 billion or an increase of 24 % from Rp 6,16 billion. The increase was in accordance with the increase in shipping income and other forms of business. According to its corporate secretary, S.L.Eng, the company's growth depends on the government's power plant, with whom the company has a contract of transporting coal to the power plant. Although the building of the power plant is possibly postponed due to currency crisis, the company persisted on providing several ships to its fleet by purchasing 4 new ships worth US\$ 7 million. By doing this, the company presently has 30 ships. Early in year 2002, Fraser Securities Pte. Ltd. Singapore bought up 11.38% of the company's shares as a long term investment.



Financial Performance: The Company still suffered net loss at IDR14.952 billion in 2007, down from IDR38.596 billion net loss in 2006. The net revenue increased from IDR15.481 billion to IDR30.166 billion.

Brief History: The company was established in 1971, under the name PT Tanda Widjaja Sakti. In December 1993, in preparation for the public offering of its share, the company changed its name to PT Steady Safe. The start-up with license to operate 150 vehicle as taxi for Jakarta has today become premier mass Transportation Company. Steady Safe has introduced the Indonesian capital's first privately managed Air Conditioned buses and now operates 12 pool and workshop in the greater Jakarta area for the logistical and technical support requirements of its taxi and bus fleets. On July 20, 1994, the company listed its share on Jakarta Stock Exchange. In 1997, the company embarked on expansion program involving the procurement of 1,000 buses, investment in passenger ferry, terminal operation, and investment in tool-road operation through the acquisition of 14.2% of the outstanding capital of PT Cipta Marga Nusaphala Persada (CMNP). These investment initiative were initially funded by bridging loan facility from Peregrine Fixed Income Limited (PFIL), while the company's debt placement overseas were being worked out. On November 28, 2001, the company and PFIL signed the Settlement Agreement that provides the final solution to the settlement of the company's US \$ 281 million debt to PFIL. SA was recently became effective on March 14, 2002 and its execution is going and is expected to be completed by the end of year 2002. The company has twelve majority-owned subsidiaries: PT Buana Metropolitan Taxi, PT Citra Pancakabrama, PT Fajar Utama Semesta, PT Has Muda Internusa, PT Infiniti Indosakti, PT Luhursatri Dwiraya, PT Mastrans Swadarma, PT Sembada Permai Sejati, PT Sonnypong Yatim, Steady Safe Finance BV, PT Volgren Indonesia, and PT Wahana Artha Sentosa.



Finance Company: The Company suffered net loss at IDR8.275 billion in 2007, while in 2006 recorded net profit at IDR9.423 billion. The net loss was in line with net revenue decrease from IDR39.316 billion to IDR27.418 billion.

Brief History: It started with a fleet of 25 vehicles in 1987 and expanded to 1,350 vehicles in 1994, but at present only 90% of them was operational. In 1994, the company's net income reached Rp 3.1 billion or an increase of 17.8% compared to Rp 2.6 billion in 1993. The company previously listed its shares on the Over the Counter stock market. Presently, the company's taxis operating in Surabaya have reached the number of 1,440. Aside from taxi services, the company also caters tourist transportation and coal loading services. In a bid to strengthen its equity portfolio, the company plans to make a right issue. Last year, the company made a debt-to-equity swap amounting to around Rp 13.33 billion.
