

ABSTRAK

Penelitian ini menggunakan pendekatan kualitatif deskriptif dimana penelitian yang digunakan untuk meneliti pada kondisi objek yang alamiah dan peneliti sebagai instrument kunci. Teknik pengumpulan data yang dilakukan menggunakan cara triangulasi atau gabungan. Data dikumpulkan dengan observasi, wawancara dan dokumentasi. Analisis data menggunakan reduksi data, penyajian data dan penarikan kesimpulan dimana tujuannya adalah untuk mengetahui secara sistematis tentang proses pembelajaran di SDI Perti Tomang selama masa endemi. Dari hasil penelitian menunjukkan bahwa pelaksanaan pembelajaran selama masa endemi dapat berjalan dengan baik walaupun sebelumnya mengalami perubahan dalam pelaksanaa pembelajaran karena dampak dari pandemi covid-19. Seperti yang kita ketahui bahwa kegiatan belajar mengajar dilakukan di sekolah namun, berbeda setelah terjadinya Covid-19. Untuk memutus mata rantai penyebaran covid-19 pemerintah Indonesia mengeluarkan kebijakan pembatasan aktifitas termasuk di dunia pendidikan. Sehingga proses pembelajaran selama pandemi covid-19 dilaksanakan secara daring.

ABSTRACT

This study uses a descriptive qualitative approach where research is used to examine the condition of natural objects and the researcher as the key instrument. Data collection techniques are carried out using triangulation or a combination. Data collected by observation, interviews and documentation. Data analysis used data reduction, data presentation and drawing conclusions where the aim was to find out systematically about the learning process at SDI Perti Tomang during the endemic period. The results of the study showed that the implementation of learning during the endemic period could run well even though previously there had been changes in the implementation of learning due to the impact of the co-19 pandemic. As we know that teaching and learning activities are carried out in schools, however, it is different after the occurrence of Covid-19. To break the chain of the spread of Covid-19, the Indonesian government issued a policy of limiting activities, including in the world of education. So that the learning process during the Covid-19 pandemic was carried out online.
