

ABSTRAK

JIHAD AKBAR, *Pengaruh Good Corporate Governance, Profitabilitas, Ukuran Perusahaan terhadap Kinerja Perusahaan Perbankan yang terdaftar di Bursa Efek Indonesia (BEI) periode tahun 2010-2012* (dibimbing oleh Adrie Putra, SE, MM).

Penelitian ini bertujuan untuk mengetahui kinerja perusahaan khususnya perusahaan perbankan melalui pengaruh *Good Corporate Governance*, profitabilitas, ukuran perusahaan terhadap kinerja perusahaan khususnya perusahaan perbankan yang terdaftar di Bursa Efek Indonesia, serta untuk mengetahui apakah perusahaan perbankan telah melaksanakan pengungkapan *Good Corporate Governance* secara penuh.

Desain penelitian menggunakan kausalitas-komparatif dimana sumber data adalah data sekunder. Sampel yang digunakan pada penelitian ini berjumlah 30 perusahaan perbankan yang *listing* di Bursa Efek Indonesia periode 2010-2012. Teknik pengambilan sampel menggunakan *purposive sampling*. Unit analisis adalah perusahaan. Analisis data menggunakan regresi linear berganda dengan alat bantu *Statistical Package for the Social Science* (SPSS)

Hasil penelitian pengujian menunjukkan bahwa *Good Corporate Governance*, profitabilitas yang berpengaruh terhadap kinerja perusahaan, sedangkan ukuran perusahaan tidak berpengaruh terhadap kinerja perusahaan. *Good Corporate Governance* berpengaruh terhadap kinerja perusahaan secara negatif dikarenakan pengungkapan *Good Corporate Governance* yang dilakukan terlalu ketat sehingga timbulah tekanan kepada *agen* sehingga kinerja *agen* menurun secara tidak langsung kinerja perusahaan pun ikut menurun, profitabilitas berpengaruh positif terhadap kinerja perusahaan artinya dengan profitabilitas yang bagus profit perusahaan akan ikut bagus dan kesejahteraan karyawan akan ditingkatkan dengan tujuan supaya kinerja perusahaan akan semakin bagus.

ABSTRACT

The purpose of this research is to determine the performance of the banking company, especially companies through the influence of good corporate governance, profitability, firm size on corporate performance in particular banking companies listed in Indonesia Stock Exchange, as well as to determine whether the banking company has been implementing good corporate governance disclosure is perpetually full.

Research design using causal-comparative where data sources are secondary data. The sample used in this study were 30 banking companies listed in Indonesia Stock Exchange 2010-2012. Using purposive sampling technique was sampling. Unit analysis company. Analysis of data using multiple linear regression with Statistical Package for the Social Science (SPSS)

The results of testing indicate that good corporate governance, which affect the profitability of the company's performance, while the size of the company does not affect the performance of the company. Good Corporate Governance affect negatively the performance of the company due to the disclosure of Good Corporate Governance which was too tight so there is pressure on the performance of an agent so that the agent is indirectly decreases the performance of the company had come down, profitability has a positive effect on firm performance synonymous with good profitability profit companies will come good and welfare of employees will be increased with the goal of the company's performance will be better
