

ABSTRAKSI

SURYATI BR SIHITE. Pengaruh *Good Corporate Governance* dan Ukuran Perusahaan Terhadap Kinerja Perusahaan Pada Perusahaan Manufaktur subsektor Makanan dan Minuman Yang Terdaftar di Bursa Efek Indonesia (BEI) Periode 2010-2015 (Dibimbing oleh Adrie Putra, SE, MM).

Penelitian ini bertujuan untuk mengetahui pengaruh *Good Corporate Governance* dan Ukuran Perusahaan Terhadap Kinerja Perusahaan Pada Perusahaan Manufaktur subsektor Makanan dan Minuman Yang Terdaftar di Bursa Efek Indonesia Periode 2010-2015. *Good Corporate Governance* diukur dengan lima variabel, yaitu Kepemilikan Manajerial, Kepemilikan Institusional, Dewan Komisaris, Dewan Direksi, Komite Audit. Ukuran perusahaan diukur dengan nilai logaritma dari total aset. Kinerja perusahaan diukur dengan *profitabilitas* (ROA).

Populasi dalam penelitian ini, yaitu perusahaan makanan dan minuman yang terdaftar di Bursa Efek Indonesia periode 2010 sampai 2015 sebanyak 72 perusahaan diambil secara purposive sampling. Data yang dikumpulkan merupakan data sekunder dengan metode dokumentasi. Sebelum dilakukan analisis data terlebih dahulu diadakan pengujian prasyarat analisis yang meliputi uji normalitas, multikolinearitas, uji heterokedastisitas dan uji autokorelasi. Metode analisis data yang digunakan adalah regresi linear berganda.

Berdasarkan hasil pembahasan penelitian dapat disimpulkan hanya kepemilikan manajerial berpengaruh signifikan terhadap kinerja perusahaan pada perusahaan makanan dan minuman, sedangkan kepemilikan institusional, dewan komisaris, dewan direksi, komite audit dan ukuran perusahaan tidak berpengaruh signifikan terhadap kinerja perusahaan pada makanan dan minuman.

ABSTRACT

SURYATI BR SIHITE. *The Influence Of Good Corporate Governance and Firm Size of Performance of Company in the Food and Beverages Company In Indonesian Stock Exchange (BEI Period 2010-2015). (Mentored by Adrie Putra, SE, MM).*

This study aims to determine the effect of Good Corporate Governance and Firm Size on Firm Performance in the Food and Beverages companies listed in Indonesian Stock Exchange in 2010 until 2015. Good Corporate Governance is measured by five variables: managerial ownership, institutional ownership, proportion of independent board of trustees, the board of directors, audit committee. Company size is measured by the logarithm of total asset value. The company's performance is measured by the proxy of profitabilitas (ROA).

The population in this research that the Food and Beverages companies listed in Indonesian Stock Exchange in 2010 until 2015 a total of 72 companies were taken by purposive sampling. the data collected is secondary data by the method of documentation. Before the first data analysis conducted testing requirements analysis covering the normality test, multikolinieritas, heterokedastisitas test and autocorrelation test. The method of data analysis used a linear regression analysis.

Based on the discussion of the results of this study concluded that only the managerial ownership on corporate performance in the company's Food and Beverages, while the Institutional Ownership, The Board Of Commissioners, A Board Of Directors, Audit Committee and Firm Size no significant effect on company's performance on Food and Beverages Company.
