Latar Belakang : Masalah rokok sudah mencapai tingkat pandemisitas karena terjadi di banyak negara di dunia dengan prevalensi yang cukup tinggi dan adanya kecenderungan peningkatan penggunaanya. Pelanggaran penerapan kawasan tanpa rokok pada *office area*. Area pelanggaran terjadi diruang lingkup karyawan non medis.

Tujuan : Mengetahui hubungan pengetahuan peraturan, pengawasan, pemberian sanksi penerapan kawasan tanpa rokok terhadap kepatuhan karyawan non medis di Krakatau Medika Hospital Kota Cilegon Tahun 2016.

Metode : Jenis penelitian ini bersifat deskriptif analitik dengan metode survey cross sectional, sampling menggunakan total sampling sebanyak 88 responden, teknik pengolahan dan analisis data dilakukan dengan uji statistic chi square dengan menggunakan program komputer.

Hasil : Berdasarkan hasil penelitian bahwa responden yang patuh pada penerapan kawasan tanpa rokok di Krakatau Medika Hospital yang memiliki pengetahuan baik (40.5%), pengawasan dilaksanakan (48,4%) dan pemberian sanksi dilaksanakan (43.2%), ketiga variabel tersebut ada hubungan yang signifikan terhadap kepatuhan karyawan non medis di Krakatau Medika Hospital.

Saran : Sebaiknya diadakan resosialisasi mengenai peraturan kawasan tanpa rokok, patroli rutin digerakkan kembali dan penegasan pemberian sanksi.

Background: Smoking Issues has reached the level of *pandemisitas* as happens in many countries around the world with high prevalence and the tendency of its increase. Violations of implementation of non-smoking area in the office area. The area of violation was occurred in the scope of non-medical employees.

Objective: To determine the relation between knowledge of regulation, supervision, and implementation of sanction in non-smoking area against of compliance of non-medical staff of Krakatau Medika Hospital of Cilegon of 2016.

Methods: This descriptive analytic study with cross sectional survey methods, sampling using a total of 88 respondents sampling, processing techniques and data analysis with chi square statistic test by using the computer program SPSS 20.

Results: Based on the research that the respondents comply with the implementation of the non-smoking area at Krakatau Medika Hospital who has good knowledge (40.5%), supervision is conducted (48.4%) and sanctions implemented (43.2%), these three variables have a significantly relationship of compliance of non-medical staff at Krakatau Medika Hospital

Suggestion: There should be resocialization the regulation of non- smoking area, reimplementation of routine patrol and affirmation of sanctions.
